#### Interview of the Month

Gladys Barrios, former Chairman of ICOM-Guatemala and Director of San Carlos University Museum (MUSAC), coordinated the Red List workshop in 2008 and contributed to the awareness campaign launching the latest *Red List of Endangered Cultural Objects of Central America and Mexico* in June 2010.

# What is the purpose of launching a Red List of Endangered Cultural Objects of Central America and Mexico?

The main mission is to increase people's awareness about heritage preservation. The Editorial Board, who gathered various representatives of the different countries in Antigua Guatemala in 2008, pointed out numerous issues about this subject.

# What is the current situation of the fight against illicit traffic of cultural properties in the region?

Unfortunately the area is highly exposed to looting and illicit trafficking of cultural goods. The archeological heritage and colonial background in this region are very rich while protection and security measures are not sufficient.

Museums are concerned about this issue as victims of robbery of invaluable artifacts that are really difficult to get back despite the fight against illicit traffic by specialised authorities.

#### How do countries work together for this fight?

We have been working together for several years for the fight against illicit trafficking in the region. Today there are Regional Agreements about the issue, and every country has dedicated institutions in order to gather a Regional Group to Fight against Illicit Traffic of cultural goods.

The Red List is a great regional mechanism for this fight. Through the institutional network founded at the regional level, together with local authorities, such as customs in each country and also through training campaigns, we can keep the fight efficient after the launch of the Red List.

#### Which is your favourite museum?

My favourite museum is definitely the University Museum of San Carlos. I worked for its founding in 1994. I led many projects about national culture and made the museum one of the most dynamic of the country.
