You are required to respond to all applicants and if the project meets the requirements, send the Endorsement Forms by 15 September 2024, 23:59 CEST.

Scenario II: Project does not meet the criteria for endorsement

If you decide to NOT endorse the project: you can use template cover email to notify the applicant that the project is not admitted to the next application step.

Dear applicant,

We thank you for contacting [name of ICOM Body] for the endorsement of your project. After careful examination, we regret to inform you that the project does not meet the requirements for an endorsement. The reason is that:

Either

(i) The judging category "P" identified for the project does not match the description. In that case, we invite you to resubmit your endorsement request with the adequate judging category.

And/or

(ii) It was concluded that the description of your project does not match the SDG targets mentioned or that the description of your project's contribution to the target (s) identified was not sufficient. Therefore, we invite you to explore other SDG targets that your project could be contributing to achieving. Following this, you can resubmit an application with the corresponding SDG Targets by the 1st of September 2024, giving more specific explanations.

And/or

(iii) Your Project Description Document was incomplete and our [ICOM Body] could not proceed with the endorsement. We invite you to submit a complete application and make a new endorsement request by the 1st of September 2024.


